Introduction

Each year Wyndham City prepares an Annual Plan and Budget which outlines the priorities for Council to deliver in the next financial year.

In January and February 2022, a number of community engagement activities were undertaken to further understand the priorities of our community.

The engagement activities included four distinct opportunities for community members to get involved:

- Ideas submitted by the community via, The Loop, Council's online community engagement platform
- Pop up conversation events where the community had the opportunity to talk with Councillors and Council Officers:
 - o Friday 4 February Point Cook
 - o Sunday 6 February Little River
 - o Friday 11 February Tarneit
 - o Sunday 13 February Werribee
- Communities of Burma Engagement Workshop on Wednesday 23 February
- Direct feedback sent to Council via email or hardcopy

Over 400 ideas were submitted to help inform the 2022/23 Annual Plan and Budget.

The outcomes of these community engagement activities are presented in the 2022/23 Annual Plan and Budget – Community Engagement Report which can be found on The Loop at https://theloop.wyndham.vic.gov.au/202223-budget-we-want-hear-you.

This report presents the outcomes from the final stage of the community engagement process for the 2022/23 Annual Plan and Budget, the Public Exhibition period.

Proposed 2022/23 Annual Plan and Budget Public Exhibition Overview

The Proposed 2022/23 Annual Plan and Budget was placed on public exhibition for a period of 28 days, concluding on Wednesday 25 May 2022. A total of 34 contributions were received by 32 community members.

Community members were able to access the Proposed 2022/23 Annual Plan and Budget via, <u>The Loop.</u> Hard copies of the Proposed 2022/23 Annual Plan and Budget and promotional material were also provided at Council Customer Service points across Wyndham, including Libraries and Community Centres. Hard copies via post were also able to be requested.

A range of Public Exhibition Pop Up events were also held where Councillors and Council Officer attended to talk about the proposed budget and answer any questions raised. These events were:



Community members were asked to review the Proposed 2022/23 Annual Plan and Budget and complete a feedback survey on The Loop. The survey asked three questions about the Proposed Budget:

- What do you think of the Proposed Budget? What are some of the things you are excited about?
- Is there anything we might have missed that you think should be included?
- Is there anything else you want to tell us?

Respondent Profile

A total of 32 people participated in providing feedback about the Proposed 2022/23 Annual Plan and Budget. These participants were from a number of different locations as shown below:



Communications Approach

The Loop, provided the community with access to the Proposed 2022/23 Annual Plan and Budget, the feedback survey as well as a range of Frequently Asked Questions and other background information.

Several communication tools were used to promote the opportunity for people to provide their feedback during the Public Exhibition period. These included:

- a video from Mayor Cr Peter Maynard
- a range of social media posts promoted via Wyndham City Councillors
- Wyndham Media Release focussing on Budget highlights
- Electronic newsletters to The Loop subscribers

Public Exhibition Responses

A total of 32 people provided their feedback during the public exhibition period of the Proposed 2022/23 Annual Plan and Budget. Some people provided multiple suggestions.

Community members were asked - What do you think of the Proposed 2022/23 Annual Plan and Budget? What are some of the things you are excited about? Their responses included:

- Ongoing works to improve roads, community infrastructure and facilities for Wyndham's growing community
- Coastal and Marine Management across Wyndham's important coastal areas
- Investment in Wyndham's open spaces and vegetation
- Increase in funding for community grants
- Spending for local libraries
- New active transport improvements and connections

Community members were also asked - *Is there anything we may have missed?* Responses to this question have been categorised into the following themes:

- Amenity
- Arts and Culture
- Growth and Development
- Infrastructure
- Natural Environment and Open Space
- Safety
- Schools and Education
- Services and Programs
- Sport and Recreation
- Transport

A high-level overview of the feedback is provided below:

- As Wyndham continues to grow, infrastructure is a high priority for residents with 28% of respondents asking for an increase in infrastructure for their local area. This includes infrastructure such as local road upgrades, new recreation spaces for young people and sport centres and facilities.
- 28% of responses highlighted the importance of preserving Wyndham's natural environment and open spaces for our community. These included preserving the banks around the Werribee River and improving access to local wetlands and waterways.
- Transport in Wyndham made up 28% of responses. These responses focussed on improved public transport and the importance of active transport including walking and cycling spending.
- 28% of responses related to the need to upgrade existing sport and recreation facilities across
 Wyndham. This includes adding seating, public toilets, under cover areas and car park
 upgrades around Point Cook, Werribee, Wyndham Vale and Manor Lakes.
- 18% of responses related to improving the general amenity of Wyndham including a focus on litter and overgrown open spaces especially in Point Cook, Wyndham Vale, Werribee South and Truganina.

- Community safety emerged as being important to residents from Point Cook, Werribee, Truganina and Hoppers Crossing with 15% of responses relating to the need for increased public lighting, traffic management and Police resources.
- An increase in Council services and support for both young and older residents and volunteers made up 12% of responses.

Appendix 1 includes Officer comments against all community responses to the questions - *Is there anything we may have missed?*

Advocacy

Many of the community responses relate to a range of infrastructure and services delivered by Council, including community centres and libraries, early years and maternal health services, and the delivery or maintenance of local parks, open spaces, and sporting reserves. Council is also responsible for the maintenance of local roads, and the provision of waste collection and disposal services.

However, some of the feedback received by the community relates to matters that fall under the responsibility of the State and Federal Government. For example, the State Government is responsible for the planning and delivery of government schools. This includes choosing the location of schools, deciding when those schools will be built, and overseeing the design and construction of schools.

They are also responsible for building and managing freeways and arterial roads (including, but not limited to, the Princes Freeway, Ballan Road and Point Cook Road). The provision of hospitals, health services and police and justice services are also the responsibility of the State, and the Federal Government is responsible for providing funding for health.

Council's Role

One of Council's key roles is that of advocated. We work with relevant stakeholders in government departments, as well as elected representatives, to make clear local needs and ensure we receive the investment in services and infrastructure we need. Advocacy takes place through several platforms, including public campaigns, formal submissions, meetings with elected representatives and staff, and regular dialogue with key government departments, agencies and bodies.

There have been several positive advocacy outcomes for the Wyndham community recently. Some of these outcomes include:

- \$2.8 million to fast-track the East Werribee Employment Precinct Structure Plan and develop a Road Map for the land
- Federal funding of \$740 million for the Western Intermodal Freight Terminal in Truganina and \$920 million for the Outer Metropolitan Ring - South Rail connection to the Western Interstate Freight Terminal.
- State funding of \$6.1 million for the Wyndham Interstate Freight Terminal (WIFT) to progress planning and development activities for the WIFT and its associated rail connection to the interstate rail freight network via the Outer Metropolitan Ring Southern corridor
- Funding for the construction of six new local schools
- \$500,000 towards planning for the Tarneit Performing Arts Centre
- \$110 million for the Werribee Mercy emergency department expansion and additional beds
- Funding for the construction of the Point Cook Police Station
- Funding for rail and bus services upgrades and improvements

Council will continue to advocacy for the needs of the Wyndham community.

Next Steps

The Proposed 2022/23 Annual Plan and Budget will be finalised and presented at the Council Meeting on Tuesday 28 June 2022 for adoption.

Three library branches are integrated within community centres. Council has a long-term Library Strategy 2018-2040 that determines future library provision, considering population growth, library model success, and funding from various sources including developers, State Government and Council. In 2022 two new models of library service will commence including a Pop Up Library and Williams Landing Library Lounge. The Rate Cap for the 22-23 financial year has been set at 1.75%. The Minister for Local Government sets the local council rate cap every financial year in line with advice from the Essential Services Commission, and is also guided by the Consumer Price Index. The rate cap limits the maximum amount a council can increase general rates and municipal charges. Total community grants funding has increased to \$1.45 Million, which represents a significant boost to the program. With Council's redesigned community grants policy, the program has seen an increase in the overall volume and quality of grant applications. Council officers will also continue to work with local group and organisations to access funding available from other levels of government. Council provides a range of planned activity groups for residents aged over 65, these are funded by the Federal Government and are aimed at supporting wellbeing through increased social connections.
Good to see road infrastructure spending. This has been wasteful in the past and slow. Palmers Rd Point Cook was a perfect example of mismanagement of funding. Very disappointed to see no swimming pool construction for Point Cook. These are vital for general health and well being across all ages. A regional football complex at 13mill is not going to suit the broad majority of the community. Really inadequate to have 1x 50 m pool for summer months open? Aqua pulse is kept largely 25m and inadequate for the Wyndham size. Please reconsider and think more broadly. Council consistently advocates to State Government for bus services and supporting infrastructure to provide public transport in new estates. Council works closely with Victoria Police on a number of safety initiatives, including support for the Neighbourhood Policing Framework. Council will deliver a number of community safety initiatives through the Empowering Communities Project in 2022/23 in partnership with the Department of Justice and Community Safety. This has been identified as a Major Initiative in the Draft budget.

Nature strip maintenance is the responsibility of the abutting land owner/resident in accordance with Council's Beautification of Nature Strip Policy - https://www.wyndham.vic.gov.au/beautification-nature-strips-policy. Notices are issued to properties that do not comply with Council Policy, requesting that appropriate action is undertaken accordingly. Council allocates significant resources for the collection of illegally dumped litter across the municipality. Illegal dumping needs to be addressed at the source which will require a comprehensive behaviour change program involving education, enforcement and services designed to support residents and businesses to manage the waste that they generate, placing responsibility onto each person to manage their litter in an appropriate way. Council offers a range of services including the kerbside bin system, street and parks litter bins, hard waste services and tip vouchers to assist residents. Duplication of Tarneit Road/Leakes Road is in the early stages of design. This includes early works of service proofing and extensive land acquisition west of Derrimut Road. The works are part of the Long Term Financial Plan with construction to commence in 2023/2024.

The Riverwalk Town Centre site has recently been subdivided to facilitate its sale to a town centre developer. The site will now likely be sold to one of the main supermarket operators or a developer who will construct the town centre. The timing of construction will be determined by this new owner based on market conditions. In relation to the sports ground, funding has been provided in the 2022/23 budget to do the Master Planning for the reserve. This is the first step in the process and will be followed by detailed design and then construction.

The environmental hub was previously considered by Council in the 2021/22 process in the following way: Refinement of the business case through a feasibility study will be developed for Council's consideration for potential implementation in 22/23 financial year. (From Email from City of Wyndham dated 24th July 2021 - see attached). Following a series of further discussions with Council Officers, it was advised that WRA: "formally submit the business case as part of the up-coming budget processBy submitting as a community submission it will allow Councillors to see your proposal and also allow officers to request additional funding for resourcing to complete a feasibility study." (From Email from City of Wyndham dated 31st March 2022 - see attached). Please find attached the business case for the environmental hub for the consideration by Council in their 2022/23 Annual Plan & Budget. WRA would be pleased to make a presentation to Council on the benefits of such an exciting project for the City of Wyndham.	Climate Futures Office	Climate Futures have been working closely with the Werribee River Association on the development of their Environmental Hub Business Case.
