## TWO NEW DOG OFF-LEASH AREAS FOR WYNDHAM

## COMMUNITY ENGAGEMENT REPORT



December 2023

## PROJECT BACKGROUND:

In 2022 Council endorsed the Wyndham Dog Off-leash Plan. This plan guides the future provision of dog friendly spaces across the municipality to ensure an even distribution accessible to all dog owners.

The consultation for the proposed fenced dog off-leash areas at Cambridge Reserve, Hoppers Crossing and Alcock Road Reserve, Truganina is part of the continued implementation of Wyndham's Dog Off-leash Plan.

Consultation on the two locations was held from 30 October to 27 November 2023 to receive feedback on the proposed designs and locations.

A summary of the consultation process and community feedback is provided below.

80\% of community feedback expressed excitement and support for the proposed fenced dog off-leash area at Cambridge Reserve.

Fantastic idea for all the dog owners in the area to have a dedicated area for their four-legged friends

Council will continue with the design and delivery of the project.

20\% of respondents (13) were not supportive of the location and/or aspects of the design and provided the following feedback on why.

Many of us residents and our children use that area to walk through to other places such as the park or school. Most of the time kids walk on their own especially when going to and from school. Currently the area is safe but if it turns into a dog off-leash area, we can say goodbye to those days

Great spot, it's a dead space not used at all, good car parks close by. No other off-leash parks close by so we really need one in this reserve.

It's a great area. Large enough for dog off leash area.

As a local to the Cambridge area where the proposed off lead dog park is being considered, I was very pleased. It would provide a great opportunity for locals to get their pets together in a controlled environment.

Fantastic idea for all of the dog owners in the area to have a dedicated area for their four-legged friends instead of just congregating on the oval and not letting the doggies be able to play with the other doggies.
Lots of trees for dogs to explore and not be focused on just other dogs. High fences are also important.
The agility equipment is a great addition for dog owners!

Its an excellent central spot for most dog owners in Cambridge Estate.
It will also ensure dog owners don't let their dogs off leash in other areas of the reserve - such as the cricket grounds which currently serve this purpose illegally and that's definitely not appreciated by the community.
